PROFILE

Mulungushi Agro settlement scheme was established in 1987 as a Zambia Consolidated Copper Mines Limited (ZCCM) Project in Conjunction with the Government of Zambia.

It is located on both eastern and western sides of Mulungushi Dam on farm number 836.

The scheme was established as a social project with the following objectives.

- a) To settle retired and redundant employees and their families. (Targeted 300 families).
- b) To generate a rural service centre for settlers and neighbouring villages.
- c) The farm was established as a pilot schemes for similar settlement schemes elsewhere in the country.

Total Land Area is about 5,500 Hectares

- Settlers - 3,800 Ha
- Commercial - 1,700 Ha

200 farmers are settled on 10 Ha farm plots engaged in crop, poultry and beef production. Major crops being maize, soybeans, cotton, sunflower and groundnuts.

Synopsis of the Area

The area with the population of approximately 1,000 plus with:-

- Serviceable Road Network

- Electricity Supply
- Office Accommodation
- Staff and Several Farm Workers Houses
