I. United Nations Millennium Development Goals and TOBB's Contribution to the Achievement of these Goals

TOBB has attached great emphasis on the United Nations Millennium Development Goals since the year 2000 and has worked in cooperation with the national authorities, policy makers and the international organizations aiming to contribute the efforts to raise the global awareness for cooperating to achieve better development throughout the region and the world.

Actually, TOBB pays efforts to encourage and contribute to sustainable development, establish global partnerships, raise people's welfare, reduce poverty, and foster peace and stability for development.

Within this framework, TOBB as the apex organization of the Turkish private sector in Turkey, assuming the mission to lead and guide the business world and being aware of its social responsibilities, proactively has taken outstanding initiatives and has carried out numerous national, regional and international projects and activities in line with the United Nations Millennium Development Goals.

Witihin this context, the "Millennium Development Goals Turkey 2005" Report, presented to the UN Member Country Representatives at the 60th General Assembly on September of 2005, was prepared with the contribution of our Union.

I. United Nations Millennium Development Goals and TOBB's Contribution to the Achievement of these Goals

TOBB has conducted numerous projects in line with the United Nations Millennium Development Goals

GOAL 1: Eradicate Extreme Poverty and Hunger

- Within the context of this goal, TOBB has donated food aid to those in need in poorer regions of Turkey and the neighbor countries.
- TOBB contributed in kind grants to the Makassed Islamic Charitable Hospital, built to serve the Palestenians in Jerusalem in 2007.

GOAL 2: Achieve Universal Primary Education

- TOBB provides educational assistance both domestically and abroad.
- TOBB continuously contributes to the construction of primary schools all over the country and in this process, 42 primary schools have been built already.

- TOBB has made in kind contributions to the "All Girls to School" Campaign, carried out by UNICEF, in Turkey, and President of TOBB, Mr. M. Rifat Hisarcıklıoğlu, the Honorary Member of the UNICEF National Committee of Turkey.
- TOBB is in the process of donating fabric and drapery goods to sew school uniforms for 101,000 students between the ages 6-11 in Gaza, Palestine, which will also provide employment, as the school uniforms will be sewed in Palestine.



GOAL 3: Promote Gender Equality and Empower Women

- TOBB established the most comprehensive women network in Turkey, the "Women Entrepreneurs Council," which targets not only improving the contribution and economic power of the women entrepreneurs in Turkey but also raising awareness on how valuable they are both for the society and for the economy.
- TOBB, assuming the Presidency of Economic Cooperation Organization Chamber of Commerce and Industry, covering Turkey, Iran, Pakistan, Afghanistan, Azerbaijan, Kyrgyz Republic, Kazakhstan, Tajikistan, Turkmenistan, Uzbekistan, also established ECO CCI Women Entrepreneurs Council where women business representatives of the respective countries come together, aiming to share an interactive cooperation platform.

GOAL 7: Ensure Environmental Sustainability

- TOBB conducts environmental programs with Tema Foundation, which works on forestation and erosion prevention.
- TOBB is also actively involved in the numerous national activities on Climate Change and carries out works in cooperation with, national agencies, UNDP, UNIDO and UNEP.

GOAL 8: Develop a Global Partnership for Development

- TOBB works in close cooperation with the Islamic Development Bank on organizing various capacity building training programs for developing countries.
- TOBB has founded Ankara Forum among Turkey-Israel-Palestine aiming to contribute the peace and cooperation in the region.
- Within the framework of Ankara Forum, aiming to establish an industrial estate so as to create employment in the West Bank, TOBB has developed the "Industry for Peace (TOBB-BIS) Project".
- TOBB has founded Istanbul Forum among Turkey-Afghanistan-Pakistan aiming to formulate a trilateral dialogue and cooperation mechanism.
- Aiming at the development of a well-functioning chamber system and to promote the development of a regional network of business organizations in the Middle East and North Africa region (MENA), TOBB carried out the "*OECD MENA Business Development Project*".

• The platform of the G - 20 Chambers was proposed by the Union of Chambers and Commodity Exchanges of Turkey (TOBB) with the idea of filling the need of a forum for the private sector representatives of G - 20 countries. "G - 20 Chambers Summit" intends to function as a platform that would enable a network of dialogue among the private sector representatives of the G - 20 countries, which would in turn contribute to the discussions on the international financial architecture.

The initial introduction of the G – 20 Chambers Summit was made on the occasion of the 6th World Chamber Congress, organized by the World Chamber Federation in Kuala Lumpur, Malaysia, in a session held on June 4, 2009.

The G-20 Chambers Summit aims to provide a new perspective on global governance of economic system that is in the formation process. The summit will also contribute to the global coordination of crisis measures as well as enhance the dialogue between chambers of the G-20 countries.

II. TOBB Participated in United Nations Global Compact

The "*Localizing Millennium Development Goals Project*," developed by the UNDP, was carried out in Turkey in cooperation with our Union. In this respect, TOBB aimed at implementing the millennium development goals at the local level through the Local Agenda 21 and encouraging partnerships among city administrations, the private sector and civil society.

Furthermore, to achieve these goals at the local level, TOBB granted a fund of 500,000 US Dollars in order to encourage active participation of these institutions.

IV. United Nations Security Council (UNSC)-Turkey's Membership to UNSC

TOBB has actively worked and contributed to the efforts on Turkey's election and representation at the UNSC. Turkey has been chosen to represent the "Western European and Others" region in the UNSC for the 1 January 2009 – 21 December 2010 term.

V. United Nations Economic Commission for Europe-Inland Transport Committee (ITC)

TOBB is an active member of the International Road Transport Union –IRU which works under the auspices of the United Nations Economic Commission for Europe. Within this mission, TOBB is the guaranteing organization in Turkey for TIR system.

One of TOBB's primary functions is to undertake the distribution of around 790.000 TIR carnets to 1400 haulers annually with a risk in excess of 30 billion Dollars. (Turkish Road Transportation Fleet is 1st in Europe, 3rd in the world)

In addition, TOBB actively attends the delegation visits of our country to the sessions of the subsidiary bodies of Inland Transport Committee (ITC) - the Working Party on Customs Questions Affecting Transport, the TIR Administrative Committee and the Working Party on Road Transport in order to share its insight on the challenges Turkey faces in the international transport sector and make contributions on attaining an effective working mechanism for the TIR system.

VI. World Tourism Organization (UNWTO)

TOBB became a member of the UNWTO, On November 2009, in order to contribute the works of UNWTO, to represent and share the experiences of the Turkish tourism sector in this international platform.

VII. United Nations Economic and Social Council-ECOSOC

TOBB was granted with Special Consultative Status by the UN Economic and Social Council, NGO Section, on July 28th of 2009. In this respect, with its vast experience and capacity to conduct projects on social development, peace building, gender equality, global public health, etc., TOBB will be a perfect partner for ECOSOC to work with. Moreover, TOBB will have a chance to cooperate with the other NGOs which are also granted with the consultative status of ECOSOC.



VIII. International Monetary Fund (IMF)

TOBB is in close contact with the IMF. The Union has received various delegations on different occasions, during which top current issues regarding the Turkish and world economy are evaluated. In addition, the Union actively participates in the events of the IMF, such as the IMF-World Bank Annual Meetings and the Civil Society Forums organized in this context.

X. World Trade Organization (WTO)

TOBB, aiming to follow the negotiations and works of WTO on implementation and monitoring of multilateral agreements and to represent the opinions of Turkish private sector applied to WTO and was accredited on December 2005 to WTO.
